IN FISCAL YEAR 2016, THE BRIDGE EXPANDED SERVICES TO INDIVIDUALS WITH AUTISM AND THEIR FAMILIES.

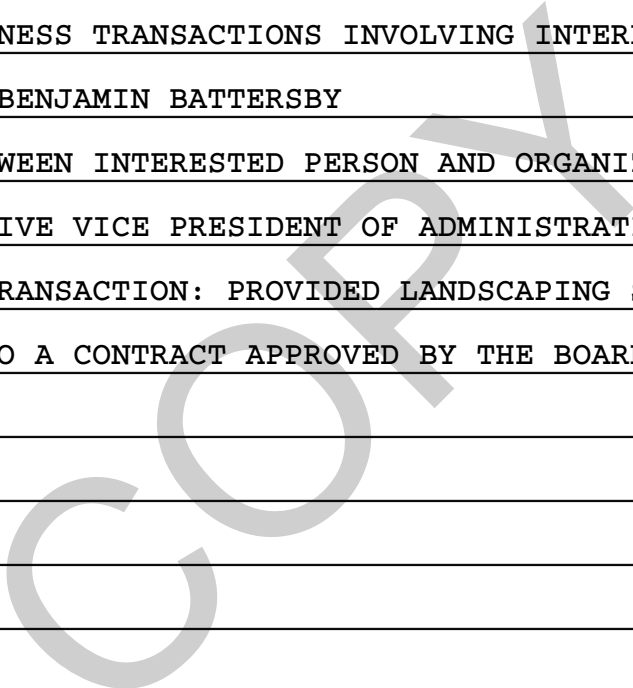
